**CARVC CAMPGROUND DUES (annual):** Campground dues are based on the total # of sites in your park (including on-site rental units) in your park, plus enrollment in Outdoor Hospitality Industry (OHI), a national organization for park operators.

- \*Parks up to 50 sites:
  - Flat rate of \$161.55 (*no per site rate*)
- \*Parks with 51-547 sites:
  - Base Rate of \$168.53
  - Per site rate of \$2.81 (for sites 51-547)  
*(subtract 50 from total sites, multiply adjusted site # by \$2.81. Add to base rate)*
- \*Parks with 548 or more sites:
  - Flat rate of \$1567.28 (*no per site rate*)

- OHI Dues:**
- \*Parks up to 510 sites:
    - Base Rate of \$157.00
    - Per site rate of \$1.45  
*(multiply total sites x \$1.45. Add to base rate)*
  - \*Parks w/ 511 or more sites:
    - Flat rate of \$900 (*no per site rate*)
